Supplementary regulations for a club restricted Time and Observation Trial open to registered members riding solo machines and held under the national sporting code of the ACU, together with these supplementary regulations.

ENTRIES: Close when full and is limited to 60 starters. All riders must be club members.
Entry fee £20, plus 2 SAE's for acceptance and results if required. Club membership £5.
Please make cheques payable to North Somerset (Bristol) Motor Sports Club.

CLASSES: Open to any type of solo machine Class 1: Trials/Trail machines on Trials tyres.
Class 2: Other machines on Trials tyre.

AWARDS: **Premier:** for the best performance in each class.
Runner Up: for the next best performance overall.
1st Class: for the next best 15% of starters in each class.
Best 'B' award for best trials intermediate not in the main awards above.
Best 'C' award for best trials novice not in the main awards above.

All awards subject to a minimum of 6 entries in the class.

COURSE: At Frys Bottom Lane, Chelwood BS39 3QN which is all on private land. 6 observed sections will be included on each lap, all of which must be attempted. Failure to attempt a section, or course cutting will result in disqualification. The course will consist of streams and woodland and the first rider to complete the most laps in **90 minutes**, or complete 16 laps (whichever occurs first) will set "standard time" (average speed not to exceed 20 mph). The course will be technical, but the observed sections will not be particularly difficult.

START Will be at 10.30 am with 2 riders away every 10 seconds, starting in numerical order.

FINISH Riders still circulating after the first rider has finished will be allowed a further 20 minutes to attempt to complete the target number of laps.

MARKING Observation: Clean 0 Time: 1 mark lost for every 30 seconds
Footing 3 over "standard time", allowing for starting
Stop or fail 5 time differential. (Max time penalty 40 marks lost).

TIES Will be decided by (a) lowest marks lost on time (b) most cleans.

CLOTHING Protective clothing, boots, helmets and gloves must be worn.

NUMBERS Numbers will be provided by the Club. These must be inserted in pockets in bibs which can be purchased from the Club for £5. Any other numbers must be removed from machines or covered with tape. All numbers must be returned immediately after the trial – penalty £10.
Riders should ensure that their number is recorded at each section and at lapscoreing.

WARNING Riders who are considered to be riding in a dangerous manner will be disqualified.
Maximum speed in blue taped areas (lapscoreing etc) is walking pace.
